1. Operating Results (Consolidated)

The Company's net profit for the first quarter 2024 was Baht 49.26 million, decreased by Baht 7.16 million or 12.68% when compared with the same quarter of the previous year. The Company's total revenues was Baht 297.97 million, decrease by Baht 3.41 million or 1.13% from first quarter last year and The Company's fees and service income was Baht 288.26 million, decrease by Baht 3.95 million or 1.35% from first quarter last year. There are 13 new mutual funds, divided to 1 equity fund, 2 mixed fund and 10 fixed income fund with a total net asset value of Baht 7,526 million compared with last year there are 4 new mutual funds, with a total net asset value of Baht 3,209 million.

As at 31 March 2024, the total assets were Baht 1,682.16 million, decreased by Baht 1.29 million or 0.08% from the amount as at the end of 2023, The main components of total assets were investment of Baht 895.30 million or 53.22% of total assets, cash and cash equivalent of Baht 283.53 million or 16.86% of total assets, accrued fees and service income from asset management business of Baht 121.11 million or 7.20% of total assets and right-of-use assets of Baht 195.10 million or 11.60% of total assets.

As at 31 March 2024, the total liabilities were Baht 453.38 million, decreased by Baht 41.01 million or 8.29% from the end of last year.

Lastly, shareholders' equity as at 31 March 2024 was Baht 1,228.78 million, increased by Baht 39.72 million or 3.34 % from the end of last year.
