The Board of Directors' Meeting of Rojana Industrial Park Public Company Limited ("Company") No. 2/2024 held on May 15, 2024 has passed a resolution to approve the sale an investment in Rayong Recycle Waste Co., Ltd. (a Joint Venture of Subsidiary) for 450,000 ordinary shares at the rate of Baht 25.00 per share totaling Baht 11,250,000 (Eleven Million Two Hundred Fifty Thousand Baht Only).

The entering into the above transaction is considered as a disposition of assets of the Company pursuant to the Notification of the Capital Market Supervisory Board No. TorJor 20/2551 (2008) Re: Entering into Material Transactions Deemed as Acquisition or Disposition of Assets and the Notification of the Stock Exchange of Thailand on Disclosure of Information and Operations of Listed Companies in Acquisition or Disposition of Assets B.E. 2547 (2004) ("the Notification on Acquisition or Disposition"). The value of the transaction size is equal to 0.06 percent, according to criteria of the Total Value of Consideration derived from the consolidated financial statement of the Company as at March 31, 2023, and when including the transactions of asset disposal within the past 6 months the value equals 0.59 percent. The value of above transaction is lower than 15 percent which is a small size item.
