The overall consolidated performance of Q1/2024 showed an operating profit of Baht 60.4 million, a decrease of 60.1%, and reported a net profit of Baht 28.7 million, a decrease of 71.9% compared with the same period of last year. The overall revenue has significantly declined due to recognize a profit of Baht 177.2 million in the divesting of the High Precision Metal Manufacturing Business (AUTO) in 2023 and the decreasing of revenue in EPC business from slowdown of investment due to Russia and Ukraine war.

Engineering Procurement Construction Business (EPC): A decrease in revenue of Baht 249.9 million or equivalent to 66.5% from the same period of last year. The EPC has an operating loss of Baht 44.6 million, which increasing in loss of Baht 39.7 million or equivalent to 810.2%.

- Water Management Business (WATER): A decrease in revenue of Baht 2.3 million or equivalent to 12.4% from the same period of last year. The WATER has an operating profit of Baht 4.4 million, which profit decrease of Baht 5.8 million or equivalent to 56.9% from an operating profit of Baht 10.2 million from the same period of last year, which affected from El Nino climate change.
- Bitcoin Mining Business (MINING): An increase in revenue of Baht 176.3 million or equivalent to 448.6% from the same period of last year. The MINING has an operating profit of Baht 110.4 million, an increase of Baht 134.8 million or equivalent to 552.5% from an operating loss of Baht 24.4 million from the same period of last year. The company has taken a profit from Bitcoin mining and profits from the sales of digital assets of Baht 32.7 million and Baht 78.3 million respectively.
