Revenues

Operating results in the first quarter of 2024, the Company and its subsidiaries had total revenue of 63.65 million baht, a decrease of 43.39 million baht or 40.54 percent compared to the same period of the previous year. This was mainly due to the reduction of revenue from sale of real estate that decreased by 47.37 million baht because the demand of housing is still likely to decrease as a result of high levels household debt and high interest rates , which reduces the ability to borrow

Cost of sales and services

Cost of sales and services in the 1st quarter of 2024 is equal to 40.43 million baht or 64.56 percent of revenue from sales and services Cost of sales and services in the first quarter of 2024 decreased by 27.80 million baht or 40.74 percent compared to the same period of the previous year due to decreased income from real estate sales.

Selling expenses

Selling expenses in the first quarter of 2024 were equal to 11.28 million baht, or 17.72 percent of total revenue. The effectiveness of sales work has not improved, so the company must urgently fix it. By finding new sales channels that has not a high cost

Administrative expenses

Administrative expenses in the first quarter of 2024 were equal to 19.25 million baht, or 30.24 percent of total revenue The company was able to control administrative expenses to decrease from the previous year by 1.10 million baht, but the revenue has dropped significantly ,causing administrative expenses as a percentage of revenue to be much higher

Financial costs

Financial costs in the first quarter of 2024 are equal to 0.70 million baht or 1.10 percent of total revenue.



Net profit

Company performance and subsidiaries in the first quarter of 2024 had a loss of 8.13 million baht, a decrease from the same period of the previous year of 13.08 million baht or a decrease of 264.24 percent due to a decrease in income. from real estate sales dropped below the break-even point

Total assets increased from 2,299.56 million baht to 2,357.99 million baht, an increase of 58.43 million baht or an increase of 2.54 percent.

Liabilities

Total liabilities increased from 1,133.77 million baht to 1,200.33 million baht, an increase of 66.56 million baht or an increase of 5.87 percent.

Shareholders' equity

Shareholders' equity decreased from 1,165.79 million baht to 1,157.66 million baht, a decrease of 8.13 million baht or a decrease of 0.70 percent from a loss for the first quarter of 2024.
