- 3. The general characteristics of the transactions:
 - 3.1 Vanachai WoodSmith Co., Ltd. prepares a warehouse lease contract of 1,500 square meters which is the project of DEPOT by VANACHAI of The Vanachai Group of Companies Co., Ltd., located at No. 51, Moo 1, Siri Sothon Road, Tambol Saen Phu Dat, Amphoe Ban Pho, Chachoengsao Province. The lease contract duration is 3 years starting from 1 July 2024 to 30 June 2027 with the purposes of being storage, distribution center, product distribution center with efficiency to customers in the East, and company office.
 - 3.2 Vanachai WoodSmith Co., Ltd. prepares the infrastructure service contract on the lease area (in total of 1,500 square meters) and on the sharing areas (ex. path, corridor, and sharing space within the lease areas). This contract gives benefits in term of company area utilization from the project of DEPOT by VANACHAI of The Vanachai Group of Companies Co., Ltd. where is located at No. 51 Moo 1, Siri Sothon Road, Tambol Saen Phu Dat, Amphoe Ban Pho, Chachoengsao Province. The leasing duration is 3 years from 1 July 2024 30 June 2027.
