The above transaction is classified as a connected transaction which supports ordinary course of business under normal commercial terms. The rental office space is situated in a good location, easily accessed whist the rental fee is considered appropriate and comparative to those in the proximate area. The transaction value amounts to Baht 17,889,300.

If such transaction is included together with the similar type of transactions occurred in the previous six- month period on July 25, 2024, August 29, 2024, October 31, 2024 and November 29, 2024, in the amount of Baht 8,687,250, Baht 7,573,995, Baht 16,881,150 and Baht 3,818,100 respectively, the connected transactions occurred in six months are totaled of Baht 54,849,795, which is greater than 0.03% (or Baht 10,148,422.50) but less than 3% (or Baht 1,014,842,250) of Net Tangible Assets of the Company and its subsidiaries as at September 30, 2024.

The directors and persons who have potential conflicts of interest did not attend the Board of Directors' meeting on this agenda, to consider and approve the connected transactions as above, and the Audit Committee are of the opinion that does not differ from the Board of Directors.
