Shareholding Structure	51% of registered capital is held by B.Grimm BeyondBridge Limited 49% of registered capital is held by Mandala Communication Company Limited
Objective of the investment	To develop, invest in, manage, and commercialize digital infrastructure, digital solutions, data infrastructure, and related technology platforms. This includes, but is not limited to, digital energy management, smart industrial solutions, and tech-enabled infrastructure, as well as any related or complementary businesses.
