Above transaction came under the scope of connected transactions for listed companies as specified in The Notification of The Capital Market Supervisory Board No. Tor Chor. 46/2568 Re: Rules on connected transactions, with a transaction size exceeding Baht 1 million but less than Baht 20 million, or exceeding 0.03% but less than 3% of Net Assets (NA), whichever is higher. In this regard, 0.03% of the Company's NA as at March 31, 2026, amounted to Baht 1.50 million, while 3% of said NA amounted to Baht 150.10 million. Accordingly, said

transaction volume warranted the Company to seek approval from The Board of Directors and to report said information to the SET, without having to seek further approval from the shareholders' meeting.

(10) Material Transactions

Transaction volume : After taking into account other material transactions with related transactions or transactions under the same project occurring during the preceding 12 months, the transaction size is less than 25%. Therefore, the Company is not required to comply with the criteria for material transactions.
