Subject: Operating Result for the six-month period ended 30 June 2026, comparing the operating results for the six-month period ended 30 June 2025.

To: President

Thai Ha Public Company Limited (the Company) would like to inform the operating result for the six-month period ended 30 June 2026, comparing the operating results for the six-month period ended 30 June 2025 as follows: -

- **Sales revenue** decreased from 168.65 million baht for the six-month period ended 30 June 2025 to 150.04 million baht in 2026, decreased by 18.61 million baht or 11.03%. The majority resulted from the decrease in export sales, caused by the recession of the global economy.

- **Gross profit margin** decreased from 11.61% for the six-month period ended 30 June 2025 to 8.10% in 2026.

- **Other income** increased from 0.58 million baht for the six-month period ended 30 June 2025 to 4.64 million baht in 2026, increased by 4.06 million baht. The majority represented the surplus of the insurance compensation over the loss of damaged assets from the summer storm in May 2026, amounting to 4.35 million baht.

- **Selling expenses** decreased from 15.13 million baht for the six-month period ended 30 June 2025 to 9.70 million baht in 2026, decreased by 5.43 million baht or 35.86% which is managed by the management and also in the line of decrease of sales revenue.

- **Administrative expenses** decreased from 27.93 million baht for the six-month period ended 30 June 2025 to 25.97 million baht in 2026, decreased by 1.96 million baht or 7.02% as a results of the management action.
