Revenue from sales and services

The Company's total revenue from sales and services for the 1-2nd Quarter 2026 decreased by THB 2.29 million or 1.35% from the same period last year, by Revenue from contract works decreased by THB 9.92 million or 20.82% mainly from Revenue in man power problem in Solar cell business unit.

Gross Profit / Gross Profit Margin

The Company's gross profit for the 1-2nd Quarter 2026 was THB 41.52 million, increased by THB 3.94 million.

Net Profit / Net Profit Margin

The Company's net profit for the 1-2nd Quarter 2026 was THB 4.30 million, equivalent to the net profit margin of 2.57%, The net profit and the net profit margin of the Company increased comparing to the same period last year, this was due to decreased in selling and administrative Expenses and finance cost.
