We, Thaivivat Holdings Public Company Limited (the “**Company**”), would like to inform the SET that, on 20 August 2026, the Company has subscribed for 15,060,000 (fifteen million and sixty thousand) newly issued ordinary shares of Tune Insurance Public Company Limited (“**Tune Insurance**”), with a par value of Baht 10 (ten Baht) per share, representing 25.1 (twenty-five point one) per cent of the total number of shares in Tune Insurance following the issuance and offering of newly issued ordinary shares to specific investors by way of private placement, at a subscription price of Baht 4 (four Baht) per share, for a total consideration of Baht 60,240,000 (sixty million, two hundred and forty thousand Baht). The transaction will be completed upon the registration of the relevant matters with the Department of Business Development, Ministry of Commerce and receipt of approval from the Office of Insurance Commission.

The purpose of this investment is to expand the Company's business opportunities in the non-life insurance business, particularly the travel insurance segment. This investment is expected to support the Company's growth and enhance its business capabilities, as well as create opportunities to further expand business cooperation and partnerships, all of which will support the Company's long-term growth.

The Company expects that this strategic partnership will be successful and will lead to sustainable mutual growth. The Company will continue to seek investment opportunities and strategic partnerships to strengthen its capabilities and competitive position, as well as to support business expansion and the development of non-life insurance products to better serve customers' needs.
