Frasers Property (Thailand) Public Company Limited (the "Company") would like to inform that on 2 April 2021, the Board of Executive Committee's Meeting no. 6/2020-2021 has resolved to approve in principle that Golden Land Property Development Public Company Limited ("GOLD"), the Company's subsidiary which the Company holds shares equivalent to 99.3%, together with the designated persons shall acquire the ordinary shares in the aggregate amount of 5,000,000 shares, equivalent to 100% of the total ordinary shares in Silom Corporation Company Limited ("SILOM"), including accept the assignment of the right to receive payment under the promissory notes issued by SILOM (SILOM has issued promissory notes to its existing shareholder in the amount of THB 457,344,170), which is equivalent to the total value of THB 1,090,000,000. In this regard, the Company has authorized the Country Chief Executive Officer and Chief Financial Officer to negotiate for the entering into the transaction. Currently, the negotiation of the transaction has already been settled, hence, the Company hereby discloses the information in relation to the entering into the transaction whereby GOLD has acquired the shares in SILOM on 26 April 2021, details of which are as follows:
