TPI Polene Public Company Limited ("the Company") would like to notify the Stock Exchange of Thailand ("the SET") that the Company's Board of Directors' meeting no. 5/2564, held on May 27, 2021, passed a resolution to approve the Company to enter into/renew the lease agreements to rent office space from Pornchai Enterprise Co., Ltd., a 0.65% owned related company that has common directors and shareholders, which is classified as a connected person. The above transactions are classified as connected transactions which support ordinary course of business under normal commercial terms. In addition, it is situated in a good location, easily accessed whist the rental fees are considered appropriate and comparative to that in the proximate area. The transaction value amounts to Baht 13,812,900. If such transaction is included together with the similar type of transaction occurred in the previous six-month period on December 22, 2020 in the amount of Baht 49,401,198, the connected transactions occurred in six months are totaled of Baht 63,214,098, which is greater than 0.03% (or Baht 13,063,317) but less than 3% (or Baht 1,306,331,730) of Net Tangible Assets of the Company and its subsidiaries as at March 31, 2021.

The directors and persons who have potential conflicts of interest did not attend the Board of Directors' meeting on this agenda, to consider and approve the connected transactions as above and the Audit Committee are of the opinion that does not differ from the Board of Directors.

The Company therefore would like to notify the SET of the transaction to keep the investors informed.
