Certified Public Accountant as of June 30, 2021. The transaction size of the transaction is less than 15% of the total value of the consideration. And combined with the size of the acquisition of assets during the past 6 months, the total asset acquisition volume was 0.18% (The maximum transaction size based on Total value of consideration).
