The Board of Directors approved to purchase 10,209,711 newly issued ordinary shares offered to the existing shareholders in proportion to their shareholding (Right Offering) of TBSP Public Company Limited ("TBSP") with a par value of 1.00 Baht per share at a price of not more than 10.00 Baht per share totaling an amount not more than 102,097,110.00 Baht, where the entering into such transaction would result in TKS maintaining the shareholding of TBSP in the proportion of 25 percent of the total number of sold shares of TBSP upon the completion of the TBSP Newly Issued Ordinary Share Purchase.

However, the Right Offering and newly issue share allocation is uncertain due to TBSP Shareholder approval in the meeting which is being held on January 7<sup>th</sup>, 2022.
