TPI Polene Public Company Limited ("the Company") would like to notify the Stock Exchange of Thailand ("the SET") that on February 24, 2022, TPI Polene Bio Organics Co., Ltd. (a 99.99% owned-subsidiary) entered into a lease agreement for office space rental from Pornchai Enterprise Company Limited, a 0.65% owned related company that has common directors, which is classified as a connected person.
