# Information Memorandum regarding the Connected Transaction of Interlink Communication Public Company Limited 

According to the Meeting of the Board of Directors of Interlink communication Public Company Limited (the "Company") No. 2/2022 held on February 23, 2022, passed a resolution to approval the Company to sell of land to Interlink Telecom Public Company Limited.

The total value of remuneration is in the amount of THB 23.65 million, which falls under the Transaction Category 4 of the Notification of the SET regarding the Disclosure of Information and Other Acts of Listed Companies concerning the Connected Transactions. The transaction size is equal to $0.70 \%$ of the Net Tangible Assets of the Company ("NTA") based on the highest remuneration. Therefore, this transaction size is considered to be larger than 0.03 percent but less than 3.00 percent of the Company's NTA according to the latest financial statements in which the equity method is applied of the Company as of December 31, 2021.
