## 3.General aspects of transaction

Nature of transaction: EKOLD shall invest in 100 cryptocurrency mining machines in an amount of up to 40

million Baht. EKOLD will purchase Bitmain Antminer S19Jpro – 104 Th mining machines or equivalent to pursue its goals regarding investment in cryptocurrency mining as mentioned in the notification letter. The investment will focus on clean cryptocurrency mining business by using clean energy. This project is expected to increase business opportunity and pave the way to help reducing global warming as well as driving decarbonization fossil fuels to avert the global climate change. The investment is the first

phase of the aforementioned project.

Pricing criteria: Market price of the mining machines ranging from 350,000 - 450,000 Baht depending on

Cryptocurrency price. The Buyer is of view that the transaction is reasonable and

comparable to market price.

Payment: Full payment upon delivery.

Source of Fund: Working capital of the Company.

Expected Benefit: The Company anticipates that blockchain technology would become the driver for

sustainable growth of the business as well as being the powerful tool to tackle global warming and climate change. The Company plans to integrate blockchain technology to add value to the core business in the future, for example, expansion of revenue channel, efficiently control production cost, ability to access customers' demand and improving business process efficiencies while maintaining transparency and stability in order to approach the goal to create sustainability in food and agricultural industry with social and

## 4. Value of securities which are issued by the listed company for the assets acquired

The transaction size is considered as asset acquisition transaction according to the Notification of the Capital Market Supervisory Board No. TorJor. 20/2551 Re: Rules on Entering into Material Transactions Deemed as Acquisition or Disposal of Assets and the Notification of the Board of Governors of the Stock Exchange of Thailand Re: Disclosure of Information and Other Acts of Listed Companies Concerning the Acquisition and Disposition of Assets B.E. 2547 (2004) (as amended).

The investment represents a transaction value of 0.84% calculated based on the Total Value of Consideration Basis. After such transaction value is combined with other asset acquisition transactions which occurred during the past 6 months, the total value of the asset acquisition transaction will be 29.95% compared with the total assets of the Company under the Consolidated Financial Statements of the Company for the period ending 31 March 2022, which were reviewed by the auditor. This asset acquisition transaction has made the cumulative transaction with the value of 15% or higher but lower than 50%. The Company shall have duty to disclose the information on the acquisition of assets of the Company to the Stock Exchange of Thailand.
