Subject: Report on related party transaction

(Financial Support from Amata Corporation Public Company Limited)

To: The President of the Stock Exchange of Thailand

This refers to negotiation between Amata VN Public Company Limited (the "Company") and Amata Corporation Public Company Limited concerning the Addendum to the Loan Agreement on September 16, 2022 at the amount of THB 450,000,000 (four hundred fifty million Baht) in accordance with the Board of Directors' Meeting of Amata VN Public Company Limited (the "Company") No. 5/2022 held on 9 August 2022 had resolved to approve the receipt of financial assistance from Amata Corporation Public Company Limited by requesting to extend the period of the long-term loan, in the amount of up to THB 450,000,000 (four hundred fifty million Baht) which the Company had borrowed from Amata Corporation Public Company Limited, referred to Loan Agreement dated 6 October 2020 ("Loan"). The Company requested to extend the period of the Loan up to 2 years from the prior repayment date (The prior repayment date is 11 October 2022, the Company requested to extend and repay on 11 October 2024.). The said financial assistance had been approved by the Board of Directors Meeting of Amata Corporation Public Company Limited No. 5/2022 held on 11 August 2022. The interest rate is referred to the cost of fund of Amata Corporation Public Company Limited plus 1.29 percent per annum. The transaction is considered a connected transaction according to the Notification of the Capital Market Supervisory Commission No. TorJor 21/2551 Re: Rules on Connected Transactions and the Notification of the Board of Governors of the Stock Exchange of Thailand (SET) Re: Disclosure of Information of Listed Company Concerning the Connected Transactions B.E. 2546 (2003), the details as follows:

#### 1. Date of Transaction

16 September 2022 (the signing date of the Addendum to the Loan Agreement at the amount of THB 450,000,000 (Four Hundred Fifty Million Baht) with Amata Corporation Public Company Limited)

### 2. Grantor of Financial Support

Amata Corporation Public Company Limited

### 3. Recipient of Financial Support

Amata VN Public Company Limited

### 4. General Description of the Transaction

The Company received financial support from Amata Corporation Public Company Limited.

### 5. Value of the Transaction

1. The Company received an unsecured long-term loan in the amount of not more than THB 450,000,000 (four hundred and fifty million baht) in accordance with the Loan Agreement dated October 6, 2020 between the Company and Amata Corporation Public Company Limited. The interest rate is referenced from MLR minus 1.50% per annum. The interest rate is 3.75% per annum. The actual interest paid in the past six months (1 February – 31 July 2022) to be included in the calculation of the size of transaction size. Thus, the size of transaction is as follows:

2. The Company requested to extend the period of the unsecured long-term loan up to 2 years from the prior repayment, in the amount of up to THB 450,000,000 (four hundred fifty million Baht) which the Company had borrowed from Amata Corporation Public Company Limited, referred to Loan Agreement dated 6 October 2020 ("Loan"). The interest rate is referred to the cost of fund of

Amata Corporation Public Company Limited plus 1.29 percent per annum. As a result, the interest rate of this Loan equals to 3.74 percent per annum. Details of the value of the transaction are as follows:

#### 6. Transaction Size

The aforementioned transaction is a receipt of financial support and considered a relateded party transaction with the transaction size of 0.79 percent of the Net Tangible Assets (NTA). The transaction size exceeds 0.03 percent of the NTA but is less than 3.00 percent of the NTA of the Company and is considered a medium size related party transaction therefore requires approval from the Board of Directors and is required to be disclosed to the Stock Exchange of Thailand according to the Notification of the Capital Market Supervisory Commission No. TorJor 21/2551 Re: Rules on Connected Transactions and the Notification of the Board of Governors of the Stock Exchange of Thailand (SET) Re: Disclosure of Information of Listed Company Concerning the Connected Transactions B.E. 2546 (2003).

# 7. Related person / conflict of interest

The Company received financial support from Amata Corporation Public Company Limited in which Amata Corporation Public Company Limited is considered a connected person by these following reasons:

- Amata Corporation Public Company Limited is the major shareholder of the Company
- 2) Mr. Vikrom Kromadit, the director and Acting Chief Executive Officer of Amata Corporation Public Company Limited, is a related person to Mrs. Somhatai Panichewa who acts as a Director and Chief Executive Officer of the Company.

# 8. Opinion of the Board of Directors

The Board of Directors considered reasons and necessity of entering into the aforementioned transaction and resolved that terms and conditions including the interest rate was in line with the market interest rate that the Company received from other financial institutions therefore the transaction was deemed appropriate and best benefited the Company.
