- Lease Period: 3 years from October 1, 2022 to September 30, 2025.

- Rental and Service Fee (Excluding VAT): Baht 234,070 per month (Previous rate was Baht 226,180 per month).
- Security Deposit (Excluding VAT): Baht 802,210 (Previous rate was Baht 778,540).
- Pricing Basis: the rental and service fee not exceeding the average rent and service fee of office buildings around the nearby area.

4. Total Transaction Value

The total value of the Office Lease Agreement is Baht 234,070 per month or equivalent to Baht 2,808,840 per year and including the security deposit of Baht 802,210, the total value is Baht 9,228,730 for the entire lease period of 3 years. Such transaction is deemed as a medium-sized transaction with transaction value exceeding 0.03 percent but less than 3 percent of net tangible asset value or equivalent to 0.41 percent of Company's net tangible asset value (Company's net tangible asset value according to the consolidated financial statements as at June 30, 2022 is Baht 2,255,471,687). Such transaction is considered as the rental or lease of immovable property of not exceeding 3 years by which the Company is required to disclose the information.

5. Reasons and Necessities of the Transaction

The previous Office Lease Agreement has expired on September 30, 2022 and the Management Committee has passed a resolution approving for the extension of the Office Lease Agreement with Phahol 8 Co., Ltd. for a 3-year period to continue as the Company's office location for its business operation.
