For the 3 months period ended March 31, 2019, the Company has total revenues at Baht 124.03 million which increased compared to the same quarter of prior year by Baht 17.75 million, resulting gross profit at Baht 7.46 million but the Company has total comprehensive loss at Baht 7.52 million. However, the loss decreased compared to the same quarter of prior year 49.45%

For the 3 months period (the 1st quarter) of year 2019, the Company has revenues from dental services at Baht 1 1 6.5 4 million, which increased compared to the same quarter of prior year by Baht 1 5.8 9 million or equivalent to 1 5.7 9 %. Revenues from dental services can be classified according the operation areas as follows:

For the 3 months period ended March 31, 2019, the Company has cost of services at Baht 114.25 million which increased compared to the same quarter of prior year by Baht 14.25 million or equivalent to 14.31% mainly due to increasing dentist remuneration, employees' salaries of the office and branches, medical supplies and other supplies, laboratory expense and tourism cost by Baht 4.46 million, Baht 2.59 million, Baht 1.72 million, Baht 2.27 million and Baht 3.18 million, respectively.

For the 3 months period ended March 31, 2019, the Company has distribution cost at Baht 5.15 million which decreased compared to same quarter of prior year by Baht 1.41 million or equivalent to 21.54% mainly due to decreasing of advertising and promotion expenses – CLMV by Baht 2.05 million (because the project was canceled) and increasing of sales incentive by Baht 0.48 million.

For the 3 months period ended March 31, 2019, the Company has administrative expenses at Baht 12.16 million which decreased compared to same quarter of prior year by Baht 1.11 million or equivalent to 8.39% mainly due decreasing of tourism expense Baht 1.53 million (because in this year the tourism expense is presented under cost of services) and decreasing of consultant fee Baht 2.01 million (because CLMV project was canceled).

Current assets at Baht 101.93 million, decreased by Baht 9.52 million or equivalent to 8.54%, mainly due to decreasing of cash and cash equivalent by Baht 11.30 million or equivalent to 17.68% (because it was used in the operation).

Land, building and equipment at Baht 147.24 million, decreased by Baht 2.72 million or equivalent to 1.81% because of the depreciation.

Assets on long-term lease at Baht 96.64 million, decreased by Baht 2.53 million or equivalent to 2.55% because of write-off the asset impairment.

2.2 Liability analysis

As at March 31, 2019, the Company has total liabilities at Baht 92.12 million which decreased from as at December 31, 2018 by Baht 6.68 million or equivalent to 6.76%.
