Subject Clarification of the Operating results (reviewed) for the third quarter 2019

We, Bangkok Post Public Company Limited, would like to report our Operating results (reviewed) for the third quarter 2019 ended 30 September 2019. Consolidated net loss attributable to equity holders of the Company was 156.3 million baht compared to consolidated net loss attributable to equity holders of the Company 59.2 million baht the same period last year, loss increased 97.1 million baht or 164.0 percent from ceasing the printing of newspaper at the Company's printing factory, which impairment of machines and spareparts 94.1 million baht and the first payment of severance for production staff 10.5 million baht were accounted. Excluding such transactions, consolidated net loss attributable to equity holders of the Company will be 51.7 million baht, decreased 7.5 million baht or 12.7 percent.

The significant results are as follows:

Consolidated sales and service income for the third quarter 2019 was 209.1 million baht compared to 293.3 million baht the same period last year, decreased 84.2 million baht or 28.7 percent.

Revenue from print media and advertising for the third quarter 2019 was 157.0 million baht compared to 230.2 million baht the same period last year, decreased 73.2 million baht or 31.8 percent, and revenue from production of television program for the third quarter 2019 was 33.2 million baht compared to 36.6 million baht the same period last year, decreased 3.4 million baht or 9.3 percent.

Consolidated cost of sales and services for the third quarter 2019 was 195.8 million baht compared to 233.7 million baht the same period last year, decreased 37.9 million baht or 16.2 percent.

Consolidated selling expenses for the third quarter 2019 was 27.6 million baht compared to 37.5 million baht the same period last year, decreased 9.9 million baht or 26.4 percent.

Consolidated administrative expenses for the third quarter 2019 was 35.7 million baht compared to 51.7 million baht the same period last year, decreased 16.0 million baht or 30.9 percent.
