- Comparing with Q2/19, our revenue is down by 8.53 million Baht and down by 58.97 million Baht when comparing with Q3/18. This is because we have to launch sales promotion for keeping the sales volume even though it affects to the sales value. Another factor is the effect of the exchange rate which results to our decreasing in sales value after turning to Baht.
- The effect of sales promotion and exchange rate cause us to have a loss for 2.63 million Baht in this quarter.
- There is no substantial change in raw material's cost.
