Ramkhamhaeng Hospital Public Company Limited would like to clarify the operation results, as follows:

- 1. Ramkhamhaeng Hospital Public Company Limited and its subsidiaries have the revenues of 4,953.74 million baht, decrease of 11.53 %. The reasons for the decrease are:
  - 1.1 In the year 2019, Ramkhamhaeng Hospital Public Company Limited and its subsidiaries have the revenues from medical treatment of 3,746.88 million baht, which is a 3.47 % increase from the previous year. The revenues can from the three hospitals are broken down as follows:

- Ramkhamhaeng Hospital	3,455.49	million baht
- Chaiyapum Ram Hospital	87.94	million baht
- Muang Loei Ram Hospital	203.45	million baht
Total	3,746.88	million baht

- 1.2 Ramkhamhaeng has revenue from selling medical supply and equipment 815.62 million baht, which increase 325.55 million baht from the previous year.
- 1.3 Ramkhamhaeng has profit from reverse the entry Allowance for doubtful accounts Loans receivable and Accrued Interest receivable in the amount of 1.20 million baht decrease of 207.01 million baht from the pervious year
- 1.4 In the year 2019, Ramkhamhaeng Hospital Public Company Limited receives dividend from investment 272.62 million baht, decrease of 14.81 million baht.
- 1.5 In the year 2018, R-Plus-Asset Company Limited which subsidiary company of Ramkhamhaeng had profit from selling land in the amount of 945 million baht and Ramkhamhaeng had lost from smash the building in the amount of 6.5 million baht. So, Ramkhamhaeng had net profit from selling asset in the amount of 938.50 million baht. There isn't any profit from selling land. In 2019
