The overall paper market in Q3 was slow. The prices of waste paper continued to drop and the demand for our paper declined. The selling prices of corrugating medium in both local and international markets weakened significantly.

As the result, the sales revenue decreased by 120,013,036.89 baht or 12.63 % (QoQ), the net profit decreased by 6,235,411.42 baht or 2.79 % (QoQ). The total revenue of the year as of end of Q3 was 185,045,300.14 baht or 6.59% lower than that of the same period last year. However, the net profit increased by 70,838,924.02 baht or 12.23%.
